- Unless specifically agreed in writing, the applicant acknowledges that credit granted are thirty (30) days less 2.5% from date of statement.
- 2. Credit facilities may be withdrawn by BOLTFAST (PTY) LTD at any time without prior notice, and BOLTFAST (PTY) LTD reserves the right to review the extent, nature, and duration of such facilities at all times.
- 3. A certificate by BOLTFAST (PTY) LTD showing the amount due and owing by the applicant to BOLTFAST (PTY) LTD at any time shall be sufficient prima facie proof of the facts therein stated for the purpose of all legal proceedings against the applicant for the recovery of the said amount.
- **4.** Ownership of the goods sold and delivered to the applicant on account shall pass from BOLTFAST (PTY) LTD only when all amounts due by the applicant to BOLTFAST (PTY) LTD shall have been paid, notwithstanding delivery of the said goods to the applicant.
- 5. Should the applicant be a limited liability company the directors agree and undertake to bind themselves and Surety/ies and Co-Principal Debtor/s in Solidum in respect of all amounts owing by the applicant to BOLTFAST (PTY) LTD. Should the Suretyship be limited in respect of the amount secured, the applicant agrees within 7 days from receipt of registered letter to this effect, to sign and amend Suretyship in event of BOLTFAST (PTY) LTD requiring same. The applicant nominates as its Domicilium Citandi Et Executandi the physical address as reflected on the face hereof, for service upon it of all notices and processes in connection with any claim for any amount due to BOLTFAST (PTY) LTD arising out of credit granted by BOLTFAST (PTY) LTD to the applicant.
- 10.
